- (370) Recreation ground long grass by gate needs to be kept strimmed
- (371) Jubilee Tree contribution of £50 agreed
- (372) Dead trees opposite Mickleham Lodge still require attention
- (373) Defibrillator to be sited outside Village Hall. Costs to be met by BHF, SCC and a local sponsor.

3. Open Forum

- (374) Roses Stores representatives from Mickleham Village Shop Ltd outlined the situation with regard to the sale of the shop, details of which are to appear in the next Parish Magazine.
- (375) Box Hill School V. Sherwood (Assistant Head) was welcomed as representative of C. Lowde (Head). Discussion took place regarding the traffic problems caused by pupils parking in the Old London Road and the number of vehicles attempting to gain access to the school at the end of the day. The problem of pupils smoking and leaving litter in various parts of the village was also discussed. The school will attempt to devise ways of alleviating these concerns.
